MODE OF MEETING

- The Securities Commission Malaysia, had, on 7 April 2022, issued a revised Guidance Note on the Conduct of General Meeting for Listed Issuers stating various mode of conducting general meetings as to be aligned with the "Transition to Endemic" phase subject to the requirements under the prevailing and applicable Standard Operating Procedures by Majlis Keselamatan Negara and the Ministry of Health ("Revised Guidance Note"). The Revised Guidance Note further states that listed issuers are encouraged to continue leveraging technology to conduct their general meeting beyond the Movement Control Order in accordance with the recommendation stated under Practice 13.3 of the Malaysian Code on Corporate Governance.
- In line with the Revised Guidance Note, Oriental 1936 Berhad ("the Company") will conduct the 86th AGM on a **FULLY VIRTUAL manner and online remote voting** via Remote Participation and Voting ("RPV") facilities which are available on Tricor's **TIIH Online** website at https://tiih.online.
- The venue of the 86th AGM is strictly for the purpose of complying with Section 327(2) of the Companies Act 2016 which requires the Chairman of the Meeting to be at the main venue of the meeting. No shareholders/proxy(ies) from the public will be physically present at the meeting venue.
- We encourage you to attend the 86th AGM via the RPV facilities. You may also consider appointing the Chairman of the Meeting as your proxy to attend and vote on your behalf at the 86th AGM.

REMOTE PARTICIPATION AND VOTING ("RPV") FACILITIES

ENTITLEMENT TO PARTICIPATE AND VOTE

- Only members whose names appear on the Register of Members as of 16 June 2023 shall be eligible to attend, speak and vote at the 86th AGM or appoint a proxy(ies) and/or the Chairman of the Meeting to attend and vote on his/her behalf. If you wish to participate in the 86th AGM yourself, please do not submit any Form of Proxy for the 86th AGM. A shareholder will not be allowed to participate in the meeting if his/her proxy(ies) has/have been registered to participate in the meeting.
- In view that the 86th AGM will be conducted on a virtual basis, a member can appoint the Chairman of the Meeting as his/her proxy and indicate the voting instruction in the Form of Proxy.

 - Members/proxies/corporate representatives/attorneys can proceed to vote on the resolutions at any time from the time when the poll is demanded on Friday, 23 June 2023 but before the end of the voting session which will be announced by the Chairman of the meeting. Kindly refer to "Procedures to Remote Participation and Voting via RPV Facilities" provided above for guidance on how to vote remotely via TIIH Online.
 - Upon completion of the voting session for the 86th AGM, the Scrutineers will verify the poll results followed by the Chairman's declaration whether the resolutions are duly passed.
