## Administrative Guide for the Eighty-Seventh Annual General Meeting (“87<sup>th</sup> AGM”) of Oriental 1936 Berhad

### **VIRTUAL MEETING VIA REMOTE PARTICIPATION AND VOTING FACILITIES ON TRICOR’S TIIH ONLINE WEBSITE**

- Oriental 1936 Berhad (“Company”) will conduct the 87<sup>th</sup> AGM on a **FULLY VIRTUAL manner and online remote voting** via Remote Participation and Voting (“RPV”) facilities which are available on Tricor’s **TIIH Online** website at <https://tiih.online>.
- The venue of the 87<sup>th</sup> AGM is strictly for the purpose of complying with Section 327(2) of the Companies Act, 2016 which requires the Chairman of the Meeting to be at the main venue of the meeting. No shareholders/proxy(ies) from the public will be physically present at the meeting venue.
- We **encourage** shareholders/proxy(ies) to attend the 87<sup>th</sup> AGM via the RPV facilities. **Shareholders may also consider appointing the Chairman of the Meeting as proxy to attend and vote on shareholders’ behalf at the 87<sup>th</sup> AGM.**

### **REMOTE PARTICIPATION AND VOTING (“RPV”) FACILITIES**

- The RPV facilities are available on Tricor’s **TIIH Online** website at <https://tiih.online>.
- Shareholders are to attend, speak (in the form of real time submission of typed texts) and vote (collectively, “participate”) remotely, if demanded, at the 87<sup>th</sup> AGM using RPV facilities from Tricor.
- Kindly refer to Procedures for RPV as set out below for the requirements and procedures.

### **PROCEDURES TO REMOTE PARTICIPATION AND VOTING VIA RPV FACILITIES**

- Please read and follow the procedures below to engage in remote participation through live streaming and online remote voting at the 87<sup>th</sup> AGM using the RPV facilities:

## Before the 87<sup>th</sup> AGM Day

Procedure	Action
1. Register as a user with TIIH Online	<p><i>[Note: If you are already a user with TIIH Online, you are not required to register again. You will receive an e-mail to notify you that remote participation is available for registration at TIIH Online. You may proceed to Procedure 2.]</i></p> <ul style="list-style-type: none"><li>Using your computer or smart phone, access to website at <a href="https://tiih.online">https://tiih.online</a>. Register as a user under the “e-Services” select “<b>Create Account by Individual Holder</b>”. Refer to the tutorial guide posted on the homepage for assistance.</li><li>Registration as a user will be approved within one (1) working day and you will be notified via e-mail.</li></ul>
2. Submit your request to attend 87 <sup>th</sup> AGM remotely	<p>Registration is open from 10.00 a.m. Monday, 13 May 2024 until the day of 87<sup>th</sup> AGM on Tuesday, 4 June 2024. Shareholder(s) or proxy(ies) or corporate representative(s) or attorney(s) are required to pre-register their attendance for the 87<sup>th</sup> AGM to ascertain their eligibility to participate the 87<sup>th</sup> AGM using the RPV.</p> <ul style="list-style-type: none"><li>Login with your user ID (i.e. e-mail address) and password and select the corporate event: <b>(Registration) ORIENTAL 1936 BERHAD 87<sup>TH</sup> AGM</b></li><li>Read and agree to the Terms &amp; Conditions and confirm the Declaration.</li><li>Select “Register for Remote Participation and Voting”.</li><li>Review your registration and proceed to register.</li><li>System will send an <b>e-mail to notify</b> that your registration for remote participation is received and will be verified.</li><li>After verification of your registration against the Register of Members as at 28 May 2024 the system will send you an <b>e-mail after 2 June 2024 to approve or reject</b> your registration for remote participation.</li></ul> <p><i>(Note: Please allow sufficient time for approval of new user of TIIH Online and registration for the RPV).</i></p>

## On the 87<sup>th</sup> AGM Day

Procedure	Action
1. Login to TIIH Online	<ul style="list-style-type: none"><li>Login with your user ID and password for remote participation at the 87<sup>th</sup> AGM at any time from 9.00 a.m. i.e. 1 hour before the commencement of meeting at 10.00 a.m. on Tuesday, 4 June 2024.</li></ul>
2. Participate through Live Streaming	<ul style="list-style-type: none"><li>Select the corporate event: <b>(Live Stream Meeting) ORIENTAL 1936 BERHAD 87<sup>TH</sup> AGM</b> to engage in the proceedings of the 87<sup>th</sup> AGM remotely.</li></ul> <p>If you have any question for the Chairman/Board, you may use the query box to transmit your question. The Chairman/Board will try to respond to questions submitted by remote participants during the 87<sup>th</sup> AGM. If there is time constraint, the responses will be e-mailed to you at the earliest possible, after the meeting.</p>
3. Online remote voting	<ul style="list-style-type: none"><li>Voting session commences from 10:00 a.m. on Tuesday, 4 June 2024 until a time when the Chairman announces the end of the session.</li><li>Select the corporate event: <b>(Remote Voting) ORIENTAL 1936 BERHAD 87<sup>TH</sup> AGM</b> or if you are on the live stream meeting page, you can select “<b>GO TO REMOTE VOTING PAGE</b>” button below the Query Box.</li><li>Read and agree to the Terms &amp; Conditions and confirm the Declaration.</li><li>Select the CDS account that represents your shareholdings.</li><li>Indicate your votes for the resolutions that are tabled for voting.</li><li>Confirm and submit your votes.</li></ul>
4. End of remote participation	<ul style="list-style-type: none"><li>Upon the announcement by the Chairman on the conclusion of the 87<sup>th</sup> AGM, the Live Streaming will end.</li></ul>

**Note to users of the RPV facilities:**

- (i) Should your registration for RPV be approved, we will make available to you the rights to join the live stream meeting and to vote remotely. Your login to TIIH Online on the day of meeting will indicate your presence at the virtual meeting.
- (ii) The quality of your connection to the live broadcast is dependent on the bandwidth and stability of the internet at your location and the device you use.

**ENTITLEMENT TO PARTICIPATE AND APPOINTMENT OF PROXY**

- Only members whose names appear on the Register of Members as at 28 May 2024 shall be eligible to attend, speak and vote at the 87<sup>th</sup> AGM or appoint a proxy(ies) and/or the Chairman of the Meeting to attend and vote on his/her behalf.
- In view that the 87<sup>th</sup> AGM will be conducted on a virtual basis, a member can appoint the Chairman of the Meeting as his/her proxy and indicate the voting instruction in the Form of Proxy.
- If you wish to participate in the 87<sup>th</sup> AGM yourself, please do not submit any Form of Proxy for the 87<sup>th</sup> AGM. You will not be allowed to participate in the 87<sup>th</sup> AGM together with a proxy appointed by you.
- Accordingly, proxy forms and/or documents relating to the appointment of proxy/corporate representative/attorney for the 87<sup>th</sup> AGM whether in hard copy or by electronic means shall be deposited or submitted in the following manner not later than **Sunday, 2 June 2024 at 10.00 a.m:**
  - (i) In Hard copy:

**VOTING**

- The voting at the 87<sup>th</sup> AGM will be conducted by way of electronic voting (e-voting).
- If poll is demanded, the Company has appointed Tricor as Poll Administrator to conduct the poll by way of electronic voting (e-voting):
  - Members/proxies/corporate representatives/attorneys can proceed to vote on the resolutions at any time from the time when the poll is demanded on Tuesday, 4 June 2024 but before the end of the voting session which will be announced by the Chairman of the meeting. Kindly refer to **“Procedures to Remote Participation and Voting via RPV Facilities”** provided above for guidance on how to vote remotely via TIIH Online.
  - Upon completion of the voting session for the 87<sup>th</sup> AGM, the Scrutineers will verify the poll results followed by the Chairman’s declaration whether the resolutions are duly passed.

**PRE-MEETING SUBMISSION OF QUESTIONS**

- The Board recognises that the 87<sup>th</sup> AGM is a valuable opportunity for the Board to engage with shareholders. In order to enhance the efficiency of the proceedings of the 87<sup>th</sup> AGM, shareholders may in advance, before the 87<sup>th</sup> AGM, submit questions to the Board of Directors via Tricor’s TIIH Online website at <https://tiih.online>, by selecting “e-Services” to login, post your questions and submit it electronically no later than Sunday, 2 June 2024. The Board of Directors will endeavor to address the questions received at the 87<sup>th</sup> AGM.

## **NO DOOR GIFTS/FOOD VOUCHERS**

- There will be no distribution of door gifts or food vouchers for the 87<sup>th</sup> AGM as the meeting will be conducted on a fully virtual basis.
